







## CONTEXT

In the context of the Complex Humanitarian Emergency (CHE) in Venezuela, which has persisted for 8 years, 60% of the population has been affected by deprivations and significant risks in various aspects of their lives. This crisis has been exacerbated due to political instability, institutional breakdown, and internal economic and social collapse. The population also faces increased disaster risks, especially from extreme weather events. Lack of access to public information and independent assessments has constrained the humanitarian response, including disaster preparedness. Figures indicate that, between 2020 and 2022, the population with humanitarian needs increased by 66%, impacting 19.7 million people as of March 2022, and at least 55% face severe deprivations in multiple sectors. Furthermore, the displaced population increased by 25%, reaching 7.7 million Venezuelans outside the country by August 2023, according to data from the R4V platform.


#### 3ISOLUTION IN VENEZUELA

3iS, registered as a civil society organization iMMAP France in Venezuela, began its work in 2018 supporting Information Management through standby partners deployed in OCHA, UNICEF, and FAO with USAID BHA funding to support the humanitarian architecture. Currently, we are working with CIVILIS HumVenezuela to support the strengthening of the capacities of the organizations that are part of this platform in disaster preparedness and information management, with the purpose that they can have better capacities to respond, participate, and influence in emergencies.

## **OBJECTIVE**

3iS aims to strengthen Civil Society Organizations (CSOs) Disaster Preparedness through a capacity-building strategy based on a participative capacity needs assessment for both CSOs and communities. Thus, 3iS will contribute to generating better quality information by supporting Venezuelan CSOs to have a more sustainable approach to the data collection, analysis, and dissemination, complementing the HumVenezuela efforts in monitoring and documenting the Venezuelan Complex Humanitarian Emergency (CHE), improving organizations' information management in Disaster Preparedness, anticipatory actions and Accountability to Affected Populations.



## **COORDINATION WITH OXFAM**

3iS coordinates all action with Oxfam and national and international organizations and, through the consortium, aims to empower national CSOs to be recognized as legitimate channels of communication between communities and the humanitarian coordination system.

#### EXPECTED RESULTS

Strengthen the capacity of civil society organizations in disaster preparedness, response, monitoring, humanitarian assistance indicators, advocacy, and decision-making.

Enhance the capabilities of civil society organizations to prepare for, respond to, participate in, and influence disaster preparedness.

3iS's result aligns with localization efforts to strengthen Civil Society Organizations capacities to be part of the humanitarian architecture and participate in making decisions that affect their communities. It is expected to support CSOs to be recognized as legitimate channels for engagement between the communities and the humanitarian coordination system and as an interlocutor and mediator before the Venezuelan state and the international community, including disaster preparedness issues.
